2. HST / GST return and conference call notes from Yvonne Perry-White. There is an invite for all chapter treasurers to meet at the ARMA Canada Conference in June 2013. Yvonne is looking into whether the chapters have to file income tax.

RE: GST/HST many chapters are not even registered with CRA. ARMA VI is registered and has filed income tax for the year 2004, 2005, 2006 & 2007. The HST backup documents have been prepared but the Application for Rebate is under question as there are a few forms to choose from. Yvonne will provide further direction.

Industry Canada was discussed and this relates to updating the Board of Directors. There is some question about how to do this. It appears that other chapters have not updated either.

Bank Accounts – a review of the responsibilities of the treasurer to seek ways to reduce bank charges.

Signatories – at least 2, but most have 3. Pre-signing cheques is discouraged.

On-line & bank card access – this is attached to an individual and expires when the signing authority changes.

Chartered accountants – most chapters try to find internal resources as this can be costly.
